#### Rider Specifications:

- Physically riders must be able an reasonable fit, well balanced on a horse at all gaits
- As a matter of safety Parelli reserves the right to recommend that you do not ride, and such a case your enrolment will be transferred to auditor status. We do not recommend a 'green' rider on a 'green' horse

#### Your Horse:

- Please do not bring horses with serious behavioural problems on a course, please contact the office to find the location of an instructor suitable qualified to assist in these cases.
- Stallions are not permitted.

#### Rider Requirements:

- A Basic Equipment kit is required comprising of a Natural Halter, 12-foot Line, Carrot Stick and ft Savvy String together with your saddle, riding boots/shoes\* and hard hat\*. For Level 2 and higher courses you will require a 22-foot line, extra Carrot Stick, Snaffle Bridle/Cradle Bridle and optional bareback pad.

#### \*Important: For insurance purposes the following are required:

- Australian Standard helmet to be worn whilst riding and recommended to be worn at any time you are with your horse.
- Appropriately heeled shoes or boots
- Parelli Approved Equipment
- Helmet must comply with current Australian Standards (PAS015 / EN1384 / AS/NZS 3838 / ARB HS 2012) and must be less than five years old from the date of manufacture
- Helmets must be properly fitted including the use of a chin strap.
- Helmets that have had a significant impact which has affected the strength of the helmet, must not be worn

#### Terms and Conditions

- No STALLIONS allowed on the course
- At any time in its absolute discretion, the INSTRUCTOR may:-
  - a) Revoke its approval for the Applicant to attend or participate in the COURSE
  - b) Recommend that the APPLICANT transfer to 'auditor' status
  - c) Make and adjustment or refund of fees if either event a) or b) occurs
- The APPLICANT agrees to release and discharge the INSTRUCTOR from any loss, liability or damage or cost that may be incurred by the INSTRUCTOR
  - a) as a result of any act or omission, whether caused by negligence of the applicant or otherwise
  - b) in respect of any injury, loss or damage any person who may accompany the APPLICANT to the COURSE may suffer whilst at the COURSE

## Riders Acknowledgement and Declaration

In consideration for being permitted to participate in the course(s) nominated, I, the undersigned, understand, acknowledge and accept that:

Horse sports are a dangerous recreational activity and horses can act in a sudden and unpredictable (changeable) way, especially if frightened or hurt.

There is significant risk that serious **INJURY** or **DEATH** may result from horse sport activities and in particular this activity.

Physically I am able and reasonable fit and well balanced on a horse at all gaits

The horse I will use on this course does not have any serious behavioural problems which may disrupt the clinic or other horses or other riders. I will accept and follow all reasonable directions of the INSTRUCTOR.

I am aware I may be held personally liable for injury or damage to other horses, people or property that is caused by myself or my horse and I have been advised that I should insure myself against such risks.

I confirm the Recreational Service Supplier has explained this document to me and I am aware of the implications, intent and effect of agreeing to signing the document. I/we furthermore confirm I/we am/are aware of the obvious risks associated with activities involving horses and I/we knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the Recreational Service Supplier (hereafter referred to as the "Releasees") or others and I **voluntarily PARTICIPATE** at my **OWN RISK** and assume sole responsibility for any injury, death or property damage I may suffer that arises from my participation in horse related activities.

I understand and acknowledge the dangers associated with the consumption of alcohol or any mind altering drugs before and during the activity and I take full responsibility for any injury, loss or damage associated with their consumption. I agree not to drink alcohol or take drugs prohibited by law before or during this activity.

I agree to follow the directions given to me and that any misconduct or refusal by me to follow any direction can result in the **CANCELLATION** of participation in the activity and my immediate removal from any horse **NO MATTER** where that may occur. I understand that any such non-compliance may result in injury, death and/or permanent disability and I agree to indemnify the Releasees against all claims made by any person as a result of my failure to comply.

I agree to wear a helmet at all times whilst riding and agree that I am solely responsible for ensuring that I wear a suitable helmet at all times and take sole responsibility for my actions.

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, **HEREBY RELEASE AND HOLD HARMLESS AND AGREE NOT TO SUE** the Recreational Service Supplier, their officers, officials, volunteers, instructors, agents and/or employees, other participants, sponsoring agencies, sponsors and if applicable, owners and lessors of premises used to conduct the activities (all of whom are referred to as "Releasees") **WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, OR loss or damage to person or property, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.**

### **Agreement to exclude, restrict or modify your rights:**

I agree that the liability of the above named Recreational Service Supplier for any personal injury that may result from the supply of the recreational services that may be suffered by me (or a person for whom or on whose behalf I am acquiring the services) is completely and unconditionally —

(a) excluded;
